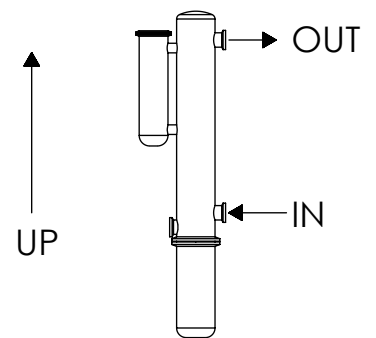
Right Side
